Summer Blowout Committee and the City of Guin reserve the right to reject occupancy to any merchandise, food or exhibits that are not in the best interest of the festival.

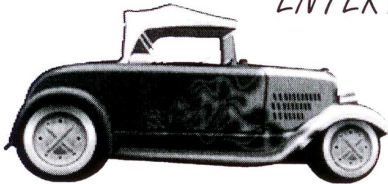
